**ST. GABRIEL THE ARCHANGEL EPISCOPAL CHURCH
COLUMBARIUM
RIGHT OF INTERMENT & CONDITIONS OF PURCHASE**

- 1. Only cremated human remains shall be interred.**
- 2. The purchase price for the right of each interment shall be \$250.00.**
- 3. Buyers shall be the natural person, personal representative, administrator, or conservator of the estate of the natural person. Buyers shall be active members of St. Gabriel congregation. The person whose remains shall be interred must be a member of the buyer's immediate family. "Immediate family" means the buyer's parents, sons, daughters, spouse of the buyer, spouse's parents, and sons and daughters of the spouse.**
- 4. The buyer shall designate the person for interment at the time of purchase.**
- 5. A religious service shall be held at each interment. A member of the clergy from St. Gabriel shall be present and supervise the service, except that such supervision may be delegated to another member of the clergy of the Episcopal Church at the discretion of St. Gabriel clergy.**
- 6. The material, size, shape and character of the marker for the location of each internment, and legend and lettering thereon shall be at the absolute discretion of the Vestry of St. Gabriel. The buyer shall pay for the marker, installation of the marker, and other associated costs incurred in installing the marker.**
- 7. No unauthorized inscriptions are permitted nor are flowers, plantings, nor other ornamentation.**
- 8. Access to the remains shall be under the control of the Vestry of St. Gabriel.**
- 9. The right of interment shall cease when St. Gabriel ceases to own the real property occupied by the Columbarium or if it is determined by the Vestry of St. Gabriel that maintenance of the Columbarium is no longer practical. In the event of such termination of said right, St. Gabriel shall remove and dispose of the remains in a manner deemed just and proper by the Vestry of St. Gabriel. Interred remains can only be removed upon a written request to the Vestry of St. Gabriel, and the Vestry's approval of the request.**
- 10. The rights of interment not used will revert back to St. Gabriel. Purchase cost will be refunded to the buyer upon written request.**
- 11. The purchase of a right of interment shall constitute the receipt of these conditions of purchase and the agreement of the purchaser to abide by these conditions. Any and all variances of these conditions must be submitted to the Columbarium Committee for approval by the Vestry of St. Gabriel.**
